

Sweepstakes Official Rules

SWEEPSTAKES IS OPEN TO PARTICIPANTS THAT ARE AT LEAST 21 YEARS OF AGE AND A LEGAL RESIDENT OF AND CURRENTLY RESIDING IN ONE OF THE 50 UNITED STATES (EXCLUDING MA, MI & VA) OR IN THE DISTRICT OF COLUMBIA.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **ELIGIBILITY:** NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.
